Membership Agreement

Students in good standing and employees of Drexel University (“Drexel”) are eligible to become members of Drexel Bike Share. As a member of Drexel Bike Share, members will be permitted to rent bicycles and related equipment (helmet, u-lock, cable and lock key)(collectively, the “Equipment”) in accordance with the terms and conditions set forth in this Membership Agreement, the Drexel Bike Share User Agreement, and in the Drexel Bike Share Policy, the terms of each of which are incorporated herein. Members must complete a User Agreement prior to each Equipment rental. Member agrees to be responsible for any loss or damage to the Equipment (an “Equipment Loss”), regardless of the cause, up to the full retail replacement cost of the Equipment. Prior to each rental, employee-members will be required to provide a valid credit card, and authorize Drexel to process a charge against the employee-member’s credit card account in the amount of any Equipment Loss. Student-members will be required to make full payment of any amounts due on account of an Equipment Loss within 7 days of the date the Equipment is due to be returned. If payment is not made within 7 days, a hold will be placed on the student-member’s records by the Drexel Registrar’s Office. Member agrees to hold harmless and indemnify Drexel and its trustees, officers, faculty, employees and/or agents from and against all causes of action, claims and demands whatsoever (including attorneys’ fees) that arise out of or are connected with member’s use of the Equipment.

Member releases and waives any and all claims, demands, or causes of action against Drexel, its trustees, officers, faculty, employees and/or agents from any and all liability for damage and injury to member and/or to any other person and/or property that arise out of or are connected with member’s use of the Equipment.
