- A separate check or money order in the amount of \$300 payable to USCIS **only** if you have dependents currently in the US who will require a change of status to H-4. This fee is typically paid by the applicant and not the department. One check (\$300) covers all dependents.

Copies of:

- Your I-94 (arrival/departure record)
- **ALL** of your I-20s or IAP-66s/DS-2019s, if you are currently in F-1 or J-1 visa status
- Your Employment Authorization Document (EAD), if you are currently in F-1 visa status and are on OPT
- A condensed curriculum vitae or résumé
- Original language university transcripts and diplomas THAT ARE RELATED TO THE POSITION YOU ARE ACCEPTING AT DREXEL; if these documents are not in English, provide an English translation.
- Copy of passport pages that include personal information and the issue and expiration dates of the passport
- Job offer/appointment letter
