Laura Lynch, PhD, received her doctorate in Couple and Family Therapy from Drexel University and completed the Families, Illness and Collaborative Healthcare Fellowship at the Chicago Center for Family Health. She has worked extensively in medical settings where she provided clinical services to individuals, couples and families coping with various health conditions and illnesses. Lynch previously served as the Director of Behavioral Medicine at the Sacred Heart Hospital Family Medicine Residency Program in Allentown, PA where she designed and implemented a behavioral medicine curriculum for resident physicians. She also co-authored the book, "Helping Children and Families Cope with Parental Illness: A Clinician's Guide." Lynch is currently clinically active at Drexel's Individual, Couple and Family Therapy Services and in Drexel's Mother Baby Connections Program. She teaches in both the Master's in Family Therapy and Doctorate in Couple and Family Therapy programs.



Adrian S. Banning, MMS, PA-C has been an assistant clinical professor in the Physician Assistant Department at Drexel University in since 2008. She was appointed research coordinator for the department in 2018. Banning is responsible for didactic portions of PA education, particularly evidence-based medicine (EBM) topics. Banning has been a PA for 11 years, having started her career in primary care with a proud focus on the veteran population before transitioning to education and developing a passion for EBM/critical thinking topics. She has authored several publications in the Journal of the American Academy of Physician Assistants (JAAPA) and the Journal of Physician Assistant Education (JPAE) and is a peer-reviewer for both journals. Banning is also a co-founding cohost of the first podcast for JAAPA. She has also presented at PAEA and AAPA. Banning is the current section editor for Exploring Medicine Through the Arts in JPAE and the former editor of the A Difficult Diagnosis section of JAAPA. She is a strong proponent of the benefits of the medical librarian-clinician team. In 2016, she was recognized in BillyPenn's, "Who's Next in Health" as one of 13 young Philly leaders shaping the health scene
