INSTITUTIONAL FINANCIAL AID APPLICATION GUIDE

The Institutional Financial Aid Application is used for Saturday Scholar, Online, Graduate and Law (Years 2 and 3) students. The information you provide on this form will be used to determine your annual cost of attendance and financial aid eligibility.

BEFORE COMPLETING THIS FORM

You will need to collect some information before you complete and submit this form to Drexel Central.

- Make sure you know your 8 digit University ID
- Speak to your academic advisor to determine what your plan of study will be for the academic year and your expected graduation date
- Determine any sources of financial assistance you will be receiving (i.e., non-Drexel Employer remission, private scholarships, awards offered to you when you were accepted to Drexel)

COMPLETING THE FORM

- Make sure you indicate if you are completing this form for the first time or are submitting a revised application
- Indicate which academic year you are submitting this form for (academic years compromise two calendar years, from September to the following September. i.e., the 2013-2014 academic year started in September 2013 and ends in September 2014. Do NOT indicate only one calendar year).
- Using the information you have discussed with your advisor, enter in the number of credit hours you will be registering for each term. (Note: There are four quarters in an academic year – Fall, Winter, Spring and Summer; and three semesters in an academic year – Fall, Spring and Summer)
- Do NOT leave any term blank; if you will not be enrolled for specific term, please indicate that with a zero.
- Make sure you indicate if you have filed a FAFSA - Eligibility for federal financial aid requires you to file a FAFSA and maintain a minimum of part-time enrollment (minimum of 6 credits a term for undergraduate students and 4.5 credits a term for graduate students)
- Make sure you identify all additional funding you expect to receive (refer to the section below, “Other Types of Financial Aid You Expect to Receive”).

IF ANY INFORMATION REGARDING YOUR REGISTRATION CHANGES FROM WHAT YOU HAVE FIRST REPORTED, YOU WILL NEED TO SUBMIT A REVISED APPLICATION TO DREXEL CENTRAL.
