AAALAC, our accreditation agency, requires all personnel handling or working near laboratory animals to have an annual health review. This will help to assure that no health problems arise as a result of your work with animals.

Those Principal Investigators who do not have direct contact with animals should still complete and submit the health form for Occupational Health review, stating on the form their role as supervisor of the research without direct animal contact.

All employees in the OSHA program must obtain their health certification through the University's Occupational Health Service.

You must contact the Department of Environmental Health & Safety at 215-895-5919 or er58@prior to going to the Occupational Safety and Health Clinic.

The following is the procedure for the Annual Health Review with Occupational Health Services.

Contact the Department of Environmental Health & Safety at 215-895-5919 or <u>er58@drexel.edu</u> to receive authorization for the Health Review. You will receive a scheduled date and time prior to going to Occupational Safety and Health Clinic.

- 1. Complete the Annual Health Review form (you can download these form from the Office of Research website at: www.research.drexel.edu go to "Quick Links" IACUC Information and forms
- 2. The Occupational Health Physician will review the Annual Health Review form and your medical history to assess the medical risk. A physical exam, additional tests and vaccinations may be recommended based on your level of animal exposure and the species of animal with which you work.
- 3. The Occupational health Physician will complete the Annual Health Review Certification Form. It is your responsibility to email the certificate to the IACUC Office at IACUC@drexl.edu and upload it into the appropriate IACUC protocols in DragonSPOT. Keep a copy for your personal records.
