## A Note from the Executive Vice Provost for Research & Innovation



Dear Colleagues,

As we begin the official launch of the Office of Sponsored Programs (OSP) within the Office of Research and Innovation (ORI) – we are excited to share with everyone the goals of this new office. Overall, the main goal of OSP is to create and facilitate a seamless and collaborative experience for those engaging in research at Drexel University and working with the ORI.

As many of you know – in an effort to improve research administration and continue to support the Drexel research community, the ORI has been working diligently to review our ongoing research administration processes and procedures. We have been working on identifying new ways of improving the research experience for all of our faculty, students and staff. The needs defined during this assessment have provided an excellent set of guiding principle for the new OSP, they include:

• We aim to increase both efficiencies and accuracy in our services in order to ensure that we are providing the state of the art research administration support

- We aim to develop "coordinated processes and procedures" that incorporate the needs/requirements of all involved in research, including ORI and other administrative and academic units across the university.
- We will prioritize communication and aim to increase transparency regarding research administration processes and procedures, by providing consistent and easily-accessible information.

To achieve this the OSP will work with the various existing ORI teams to define a new continuous approach to providing research administrative service across the lifespan of research projects/programs. Currently this includes the ORI Grants and the ORI Contracts teams. As we move forward we will work closely with the various ORI teams, such as Compliance, Applied Innovation and IRB/ULAR to outline a process for integrating their work along the timeline of a research administration. In addition, we will work with those in our research community, such as Research Accounting Services (RAS) and other administrative units to coordinate our efforts to developing new processes that better outline the roles, responsibilities and contributions of the various aspects of research administration.

While, there is much work that needs to be done – we are excited to officially launch the efforts of the OSP under the leadership of it's new Director, Gina Goodrich. We look forward to communicating our initiatives and welcome any suggestions as we embark on this exciting new work!

#### Introducing Multi-year Labor Encumbrances for Externally Sponsored Research Funds

The Comptroller's Office is pleased to announce the launch of the multi-year labor encumbrance feature for externally sponsored research funds in *Banner* and *Web\*Finance* beginning in July 2021 for **FY'22**. Multi-year labor encumbrances are a feature in Banner that allows labor (salary and fringe) to be encumbered through the budget period end date on an award. Currently, the system only calculates the encumbrance through June 30 of any fiscal year, regardless of the budget period end date on the award. As those of you in the research community are aware, externally sponsored grants do not always follow a fiscal year and can have an end date of any month in the calendar. Implementation of this feature will allow for improved financial administration of an externally funded award since your labor encumbrances will now match the corresponding budget period.

## Dr. Adam Fontecchio, Director of CASTLE, awarded ASEE Benjamin Garver Lamme Award

The American Society for Engineering Education (ASEE) has awarded Dr. Adam Fontecchio<sup>4</sup>, Professor in the Electrical and Computer Engineering Department and Director of Drexel's Center for the Advancement of STEM Teaching and Learning Excellence (CASTLE), the 2021 ASEE Benjamin Garver Lamme Award. This award is bestowed upon a distinguished engineering educator for contributions to the art of teaching, contributions to research and technical literature and achievements that contribute to the advancement of the profession of engineering college administration.

## Director of White House Office of Science and Technology Policy (OSTP) is confirmed

The Senate has confirmed Eric Lander as director of the White House Office of Science and Technology Policy (OSTP). Lander is the 11th person to hold the job since Congress created it in 1976 and the first biologist. He is also the first OSTP director to have a seat on the president's Cabinet, giving him a central role in administration policymaking.

## Senate Overwhelmingly Passes Bill to Bolster Competitiveness including research funding

The Senate passed bipartisan legislation on June 8th that would authorize billions of dollars in funding for technology research in the United States, much of which would be available for institutions of higher education. If the U.S. Innovation and Competitiveness Act -- intended to help the U.S. better compete with China -- passes the House as is, the National Science Foundation would receive \$81 billion over five years, beginning in fiscal year 2022. The bill is largely centered around "key technology focus areas," which include artificial intelligence, advanced computing, robotics and automation, natural disaster prevention or mitigation, biotechnology and data storage and management.

#### **Scientific Replication Crisis**

Alarm about a 'replication crisis' launched a wave of projects that aimed to quantitatively evaluate scientific reproducibility: statistical analyses, mass replications and surveys. Such efforts, collectively called metascience, have grown into a social movement advocating broad reforms: open-science

Several PIs have asked me for information regarding the Vertebrate Animals Section (VAS) on the NIH grant application. Knowing what information to include can be confusing and may not be the same as what you submit to the Institutional Animal Care and Use Committee (IACUC). Adding to the confusion, is the fact the questions on the VAS have recently changed. The Office of Laboratory Animal Welfare (OLAW) of NIH has a great on-line resource page on the VAS as well as an on-line training module to guide you through the process. ## Did you know that, in contrast to tuition, Drexel's F&A cost recovery is not revenue but a repayment of costs already sustained?

Every sponsored project/program has both Direct and Indirect costs.

The federal government has established what costs may be charged as direct costs and what costs are considered included in indirect costs.

Direct costs are those costs that can be identified specifically with a particular sponsored project, instruction, other sponsored activity or other institutional activity relatively easily with a high degree of accuracy.

The terms "Facilities & Administrative Costs," "F&A costs" "Indirect Costs," "IDCs" and "overhead" are often used interchangeably. The F&A (Facilities & Administrative) rate agreement is set by the U.S. Department of Health & Human Services.

*F&A cost recovery is a reimbursement of expenditures* to cover some portion of the *Indirect (F&A) costs* incurred as a function of completing a research award.

Drexel guidelines on the use of F&A cost recovery reimbursement are posted on the Office of the Comptroller website<sup>11</sup>.

A comprehensive definition of Direct and Indirect (F&A) costs be found at the U.S. Government Publishing Office website, Uniform Administrative Requirements, Cost Principles and Audit Requirements for Federal Awards issued by the Office of Management and Budget<sup>12</sup> (Uniform Guidance).


