## A Note from the Executive Vice Provost for Research & Innovation



Dear Colleagues,

Drexel's research ramp up has been a health and safety success, with no documented cases of COVID-19 transmission in laboratory, field or other research settings. This success is due in large part to the diligence of the research community. Thank you!

We are planning for a change in the density for approved researchers in specific research settings. We will announce the specifics of this change in a separate email to the research community. This will be an intermediate step prior to getting to the "new normal" in Phase 3 of the University's research ramp up<sup>1</sup>. We anticipate transitioning to the Phase 3 of the research ramp up prior to the beginning of the fall terms.

Improvements in the public health landscape are a direct result of rising vaccination rates that have driven down cases and hospitalizations here at Drexel, in Philadelphia, and the nation. We urge you to take advantage of free vaccination clinics held on Drexel's campus. For the fall term, students will be required to be vaccinated. For more information on vaccinations click here.<sup>2</sup> Feel free to upload your vaccination records to the Drexel Health Check app. Until the vaccination requirement takes effect, vaccination status cannot be used to make density-related decisions about research spaces, even if provided voluntarily. On May 19th Drexel public health experts discussed the COVID-19 vaccine and answered questions that the Drexel community had about this vaccine. ### **Drexel Names New Computing Cluster After Historic Alumna**

Back in 2014, when researchers affiliated with Drexel University's University Research Computing Facility<sup>4</sup> (URCF) were deciding the name of its first high-performance computer cluster, they went with an ancient, mythological choice: Proteus, the shape-changing sea god from Greek mythology.

When naming its replacement computer cluster, the URCF went with something a little closer to home. Picotte, which opened in February, is named in honor of Susan La Flesche Picotte<sup>5</sup> (1865-1915), MD, who, according to current research, was the first Native American to become a physician in the U.S.

On May 3rd, the 2021 Warren Alpert Foundation Prize was awarded to scientists Lynne Maquat and Joan Steitz for seminal discoveries in the biology and function of RNA, the workhorse molecule of cells. Their discoveries have reshaped the understanding of RNA's myriad roles in healthy cellfunction and in disease-causing dysfunction and have informed the conceptualization and design of RNA-based therapies in various stages of development. # Nature Publishing Group - Tackling systemic racism requires the system of science to change

In response to the global Black Lives Matter protests, many institutions pledged actions to combat racism. That's not enough. This week marks a year since the murder of George Floyd, and nearly a year since the Black Lives Matter protests compelled numerous institutions — including many in research — to acknowledge systemic racism. These events made universities, institutes, corporations, museums, societies, publishers, and funders confront racial injustice in a way that had never happened before.

# NIH Updated Biographical Sketch and Other Support Format Pages Available Now and Required January 2022

As recently announced, updated bio sketch and other support format pages and instructions are available for use in applications, Just-in-Time (JIT) Reports, and Research Performance Progress Reports (RPPRs). Use of the new format pages is preferred immediately and required for due dates and submissions on or after January 25, 2022 (NOT-OD-21-110). This represents a change from the original May 25, 2021 requirement date for the updated formats and other support signatures. Applicants and recipients can use this time to align their systems and processes with the new formats and instructions. Failure to follow the appropriate formats on or after January 25, 2022 may cause NIH to withdraw applications from or delay consideration of funding.

#### Summary:

The NIH Director's Pioneer Award Program supports individual scientists of exceptional creativity who propose highly innovative research projects with the potential to produce a major impact on broad, important areas relevant to the mission of NIH. For the program to support the best possible researchers and research, applications are sought which reflect the full diversity of the nation's research workforce. Individuals from diverse backgrounds and from the full spectrum of eligible institutions in all geographic locations are strongly encouraged to apply to this Funding Opportunity Announcement. In addition, applications in all topics relevant to the broad mission of NIH are welcome, including, but n ot limited to, topics in the behavioral, social, biomedical, applied, and formal sciences and topics that may involve basic, translational, or clinical research. To be considered pioneering, the proposed research must reflect substantially different scientific directions from those already being pursued in the

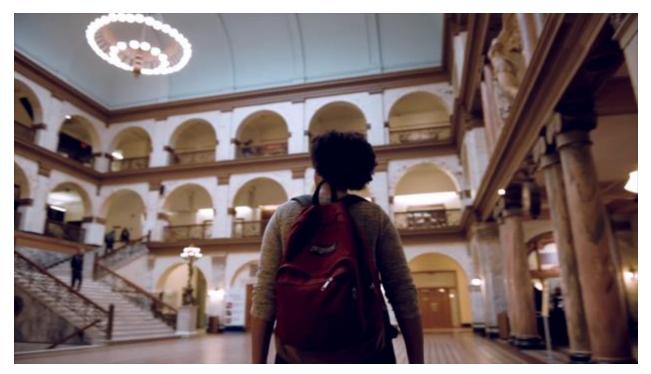
