SUMMARY ANNUAL REPORT FOR DREXEL UNIVERSITY DEFINED CONTRIBUTION RETIREMENT PLAN

This is a summary of the annual report for the Drexel University Defined Contribution Retirement Plan (Employer Identification Number 23-1352630, Plan Number 103) for the plan year January 1, 2022 through December 31, 2022. The annual report has been filed with the Employee Benefits Security Administration, as required under the Employee Retirement Income Security Act of 1974 (ERISA).

Basic Financial Statement

Benefits under the plan are provided by insurance contracts and a trust fund. Plan expenses were \$76,830,567. These expenses included \$271,672 in administrative expenses and \$76,414,705 in benefits paid to participants and beneficiaries and \$144,190 in certain deemed distributions. A total of 15,608 persons were participants in or beneficiaries of the plan at the end of the plan year.

The value of plan assets, after subtracting liabilities of the plan, was \$1,448,741,619 as of the end of the plan year, compared to \$1,686,435,028 as of the beginning of the plan year. During the plan year the plan experienced a change in its net assets of -\$237,693,409. This change includes unrealized appreciation or depreciation in the value of plan assets; that is, the difference between the value of the plan's assets at the end of the year and the value of the assets at the beginning of the year or the cost of assets acquired during the year. The plan had total income of -\$160,862,842, including employer contributions of \$34,152,572, employee contributions of \$30,992,290, other contributions of \$5,320,249, other income of \$948,631, and earnings from investments of -\$232,276,584.
